Standing Committees

Affiliate Affairs - Develops and maintains communication among contractor members and affiliated support industries and professionals. Committee members organize events for the chapter throughout the year to provide opportunities for networking, education and social interaction; members also assist in the planning of annual chapter events.

Apprenticeship Craft & Training - Establish policy, procedure and curriculum for the open shop apprenticeship program.

Employment Practices Advisory Committee - This committee involves affiliate and contractor members as well as agency members in discussion of practical human resource issues and effective resolution methods.

Environmental Professionals Council – Learn the latest environmental/regulatory developments likely to impact the way you do business. Committee members will learn about breaking issues to ensure their company operations are in compliance.

Safety Professionals Council - Develops and disseminates safety information and oversees related training and educational programs. Participants of this committee include chapter contractor and affiliate members, State Mine Inspector, MSHA, ADOT, OSHA, Arizona Public Service (APS), Arizona Blue Stake, etc.

Young Constructors Forum (YCF) – invitation only group – annual selection of new applicants. The forum serves to address and assist the next generation of construction leadership. Quarterly networking, group meetings, educational opportunities and philanthropic endeavors are the primary focus for this forum.

Joint Cooperative Committees

ADOT-AGC - Through this committee chapter members, Arizona Department of Transportation (ADOT) staff and the Federal Highway Administration (FHWA) have a forum to discuss issues and resolve problems.

AGC / ARPA Asphalt Paving and Technical Group – This joint industry group along with Arizona Rock Products Association focuses on municipal and state asphalt construction specifications and technical issues pertaining to pavements.

Alternative Project Delivery Methods (APDM) - This Adhoc cooperative was designed for Contractors, Owners and the Consulting community to work through issues and improve the current delivery methods used in horizontal construction.

Prescott-Yavapai County-AGC - A forum to discuss issues and resolve problems is provided for AGC members and staff from the City of Prescott, Town of Chino Valley, Town of Prescott Valley, and Yavapai County.
